



## **Monitor Dynamics Receives Orders for the SAFEnet Unified Security Platform from Federal Government and Defense Agencies**

SAN ANTONIO, Texas – Monitor Dynamics, the leader in Unified Access Control, Intrusion Detection and Government Identity Compliance, announced that it has received multiple purchase orders for the SAFEnet Unified Security Platform at multiple Government and Department of Defense (DoD) facilities across the United States. The SAFEnet solution was chosen because of its ability to take on customized security requirements and provide PIV and PIV-I card validation in compliance with FIPS 201 mandates, for these multiple DoD operating locations. The installation has over 50 tenant commands including a Marine Aviation Training Support Group, a Search and Rescue Unit, and aircraft for operational support airlift and fleet logistic support.
